Introduction and Approval of Previous Meeting Minutes

Funding Request

The following project was deemed consistent with the Niagara River Greenway Plan as determined by the Niagara River Greenway Commission on September 10, 2024:

Niagara Falls State Park Wayfinding Signage Project:

FUNDING REQUEST......\$550,000.00

John Honan presented the Niagara Falls State Park Wayfinding Signage Project. The project will complete wayfinding signage design and constructions drawings for parks along the Niagara River Corridor. The parks included in this wayfinding project included Niagara Falls State Park, Whirlpool State Park, Devil's Hole State Park, and DeVeaux Woods State Park. The improved wayfinding system will upgrade all signage to current NYSOPRHP standards, provide standardization throughout the Niagara River Corridor parks, and properly integrate the Niagara River Greenway Shoreline Trail. The project will include new maps with consistent messaging and graphics designed to communicate, increase awareness and accessibility, and inform visitors along this five-mile corridor. Carol Sampson favored the initiative's goal of public awareness and great connectivity. Mark Mistretta noted wayfinding to integrate the park/city seamless connection. Anticipated total construction cost is \$4 million. Proposed project final design completion is August 2025 and advertisement, fabrication, construction, and substantial completion by September 2026. It was noted the project may be implemented in phases depending on total project costs and available construction funding.

- Requesting NYS Parks Greenway funding be approved for the project.
- Carol Sampson motioned to approve NYS Parks Greenway funding for the project. Seconded by Mark Mistretta. The vote was unanimous.
